This agreement is between **Load Media ("we" or "us")**, of 10 Mercurio Drive, Flinders Park, SA, 5025 and **The Customer ("you")**.

1. **The customer** hereby agrees that by accepting the quote provided by **Load Media** and selecting "I accept", you agree to be bound by the following terms and conditions which you have read and understood. Load Media reserves the right to modify these terms, for any reason at any time.

#### 2. WARRANTIES & COPYRIGHT

- (a) Load Media warrants that it will provide its service with due skill and care and any material supplied by it in connection with those services will be reasonable fit for the purpose for which they are supplied.
- (b) You warrant and represent that you are the owner of the copyright and other intellectual property rights or have the necessary licence in the videos it has requested Load Media to reproduce and / or to modify. We acknowledge that you or the copyright owner of such videos will continue to retain all intellectual property rights, including but not limited to copyright, for such videos when copied; or
- (c) You warrant and represent that you have, where necessary, acquired (and can produce upon reasonable request by us) all necessary waivers, consents, releases, permissions and licences in connection with each video, including but not limited to image consent, model consent or subject matter consent; or
- (d) You warrant that each video does not depict subject matter in a manner that violates any laws or individual rights (including a law relating to decency, censorship, publicity or privacy), court order or other ruling of a governmental agency.
- (e) You will not subject Load Media to any liability.
- (f) You indemnify Load Media against any loss, damage and expense which Load Media may incur, whether directly or indirectly, as a result of or in connection with:

  - ii) the supply or non-supply of our facilities, equipment or services to you.

#### 3. QUOTES

Quotes are valid for 1 month. Load Media reserve the right to revise the quoted price if the information provided by you was incorrect or incomplete. If there are any variation to the quoted price due to any reason, we will notify you of the variation.

### 4. GIFT VOUCHERS
